Stochastic Processes and Random Matrices

Aug 16 2021 The field of stochastic processes and Random Matrix Theory (RMT) has been a rapidly evolving subject during the last fifteen years. The continuous development and discovery of new tools, connections and ideas have led to an avalanche of new results. These breakthroughs have been made possible thanks, to a large extent, to the recent development of various new techniques in RMT. Matrix models have been playing an important role in theoretical physics for a long time and they are currently also a very active domain of research in mathematics. An emblematic example of these recent advances concerns the theory of growth phenomena in the Kardar-Parisi-Zhang (KPZ) universality class where the joint efforts of physicists and mathematicians during the last twenty years have unveiled the beautiful connections between this fundamental problem of statistical mechanics and the theory of random matrices, namely the fluctuations of the largest eigenvalue of certain ensembles of random matrices. This text not only covers this topic in detail but also presents more recent developments that have emerged from these discoveries, for instance in the context of low dimensional heat transport (on the physics side) or integrable probability (on the mathematical side).

Supersymmetric Mechanics - Vol. 3 Oct 30 2022

This is the third volume in a series of books on general topics in supersymmetric mechanics. This collection presents material from the well established international and annual INFN-Laboratori Nazionali di Frascati Winter School on the Attractor Mechanism.

Mass Dimension One Fermions Nov 30 2022

In 2005, Dharam Ahluwalia and Daniel Grumiller reported an unexpected theoretical discovery of mass dimension one fermions. These are an entirely new class of spin one half particles, and because of their mass dimensionality mismatch with the standard model fermions they are a first-principle dark matter candidate. Written by one of the physicists involved in the discovery,

this is the first book to outline the discovery of mass dimension one fermions. Using a foundation of Lorentz algebra it provides a detailed construction of the eigenspinors of the charge conjugation operator (Elko) and their properties. The theory of dual spaces is then covered, before mass dimension one fermions are discussed in detail. With mass dimension one fermions having applications to cosmology and high energy physics, this book is essential for graduate students and researchers in quantum field theory, mathematical physics, and particle theory.

Evolution of Black Holes in Anti-de Sitter Spacetime and the Firewall Controversy

Feb 19 2022 This thesis focuses on the recent firewall controversy surrounding evaporating black holes, and shows that in the best understood example concerning electrically charged black holes with a flat event horizon in anti-de Sitter (AdS) spacetime, the firewall does not arise. The firewall, which surrounds a sufficiently old black hole, threatens to develop into a huge crisis since it could occur even when spacetime curvature is small, which contradicts general relativity. However, the end state for asymptotically flat black holes is ill-understood since their curvature becomes unbounded. This issue is avoided by working with flat charged black holes in AdS. The presence of electrical charge is crucial since black holes inevitably pick up charges throughout their long lifetime. These black holes always evolve toward extremal limit, and are then destroyed by quantum gravitational effects. This happens sooner than the time required to decode Hawking radiation so that the firewall never sets in, as conjectured by Harlow and Hayden. Motivated by the information loss paradox, the author also investigates the possibility that "monster" configurations might exist, with an arbitrarily large interior bounded by a finite surface area. Investigating such an object in AdS shows that in the best understood case, such an object -- much like a firewall -- cannot exist.

Search for New Physics in $t\bar{t}$ Final States with Additional Heavy-Flavor Jets with the ATLAS Detector

Oct 18 2021 This doctoral thesis focuses on the search for new phenomena in top-antitop quark ($t\bar{t}$) final states with additional b-quark jets at the LHC. It uses the

full Run 1 dataset collected by the ATLAS experiment in proton-proton collisions at $\sqrt{s}=8$ TeV. The final state of interest consists of an isolated lepton, a neutrino and at least six jets with at least four b-tagged jets, a challenging experimental signature owing to the large background from $t\bar{t}$ +heavy-flavor production. This final state is characteristic of $t\bar{t}H$ production, with the Higgs boson decaying into $b\bar{b}$, a process that allows direct probing of the top-Higgs Yukawa coupling. This signature is also present in many extensions of the Standard Model that have been proposed as solutions to the hierarchy problem, such as supersymmetry or composite Higgs models, which predict the pair production of bosonic or fermionic top quark partners, or the anomalous production of four-top-quark events. All these physics processes have been searched for using an ambitious search strategy that has been developed on the basis of a combination of state-of-art theoretical predictions and a sophisticated statistical analysis to constrain in-situ the large background uncertainties. As a result, the most restrictive bounds to date on the above physics processes have been obtained.

Heterogeneous Data Management, Polystores, and Analytics for Healthcare Feb 28 2020 This book constitutes revised selected papers from two VLDB workshops: The International Workshop on Polystore Systems for Heterogeneous Data in Multiple Databases with Privacy and Security Assurances, Poly 2020, and the 6th International Workshop on Data Management and Analytics for Medicine and Healthcare, DMAH 2020, which were held virtually on August 31 and September 4, 2020. For Poly 2020, 4 full and 3 short papers were accepted from 10 submissions; and for DMAH 2020, 7 full and 2 short papers were accepted from a total of 15 submissions. The papers were organized in topical sections as follows: Privacy, Security and/or Policy Issues for Heterogeneous Data; COVID-19 Data Analytics and Visualization; Deep Learning based Biomedical Data Analytics; NLP based Learning from Unstructured Data; Biomedical Data Modelling and Prediction.

Elementary Introduction to Quantum

Geometry May 13 2021 This graduate textbook provides an introduction to quantum gravity,

when spacetime is two-dimensional. The quantization of gravity is the main missing piece of theoretical physics, but in two dimensions it can be done explicitly with elementary mathematical tools, but it still has most of the conceptual riddles present in higher dimensional (not yet known) quantum gravity. It provides an introduction to a very interdisciplinary field, uniting physics (quantum geometry) and mathematics (combinatorics) in a non-technical way, requiring no prior knowledge of quantum field theory or general relativity. Using the path integral, the chapters provide self-contained descriptions of random walks, random trees and random surfaces as statistical systems where the free relativistic particle, the relativistic bosonic string and two-dimensional quantum gravity are obtained as scaling limits at phase transition points of these statistical systems. The geometric nature of the theories allows one to perform the path integral by counting geometries. In this way the quantization of geometry becomes closely linked to the mathematical fields of combinatorics and probability theory. By counting the geometries, it is shown that the two-dimensional quantum world is fractal at all scales unless one imposes restrictions on the geometries. It is also discussed in simple terms how quantum geometry and quantum matter can interact strongly and change the properties both of the geometries and of the matter systems. It requires only basic undergraduate knowledge of classical mechanics, statistical mechanics and quantum mechanics, as well as some basic knowledge of mathematics at undergraduate level. It will be an ideal textbook for graduate students in theoretical and statistical physics and mathematics studying quantum gravity and quantum geometry. Key features: Presents the first elementary introduction to quantum geometry Explores how to understand quantum geometry without prior knowledge beyond bachelor level physics and mathematics. Contains exercises, problems and solutions to supplement and enhance learning

Effective Field Theory in Particle Physics and Cosmology Jul 15 2021 The topic of the CVIII session of the Ecole de Physique des Houches, held in July 2017, was Effective Field Theory in Particle Physics and Cosmology.

Effective Field Theory (EFT) is a general method for describing quantum systems with multiple length scales in a tractable fashion. It allows to perform precise calculations in established models (such as the Standard Models of particle physics and cosmology), as well as to concisely parametrise possible effects from physics beyond the Standard Models. The goal of this school was to offer a broad introduction to the foundations and modern applications of Effective Field Theory in many of its incarnations. This is all the more important as there are precious few textbooks covering the subject, none of them in a complete way. In this book, the lecturers present the concepts in a pedagogical way so that readers can adapt some of the latest developments to their own problems. The chapters cover almost all the lectures given at the school and will serve as an introduction to the topic and as a reference manual to students and researchers.

Symmetries of Maldacena-Wilson Loops from Integrable String Theory Oct 06 2020

The book discusses hidden symmetries in the Anti-de Sitter/conformal field theory (AdS/CFT) duality. This duality is a modern concept that asserts an exact duality between conformally invariant quantum field theories and string theories in higher dimensional Anti-de Sitter spaces, and in this way provides a completely new tool for the study of strongly coupled quantum field theories. In this setting, the book focuses on the Wilson loop, an important observable in four-dimensional maximally supersymmetric gauge theory. The dual string description using minimal surfaces enables a systematic study of the hidden symmetries of the loop. The book presents major findings, including the discovery of a master symmetry for strings in general symmetric spaces, its relation to the Yangian symmetry algebra and its action on the minimal surfaces appearing in the dual string description of the Wilson loop. Moreover, it clarifies why certain symmetries are not present on the gauge theory side for purely bosonic Wilson loops and, lastly, how the supersymmetrization of the minimal surface problem for type IIB superstrings can be undertaken. As such, it substantially increases our understanding and use of infinite dimensional symmetries occurring in the

AdS/CFT correspondence.

Algebraic and Analytic Aspects of Integrable Systems and Painlevé Equations Nov 18 2021

This volume contains the proceedings of the AMS Special Session on Algebraic and Analytic Aspects of Integrable Systems and Painlevé Equations, held on January 18, 2014, at the Joint Mathematics Meetings in Baltimore, MD. The theory of integrable systems has been at the forefront of some of the most important developments in mathematical physics in the last 50 years. The techniques to study such systems have solid foundations in algebraic geometry, differential geometry, and group representation theory. Many important special solutions of continuous and discrete integrable systems can be written in terms of special functions such as hypergeometric and basic hypergeometric functions. The analytic tools developed to study integrable systems have numerous applications in random matrix theory, statistical mechanics and quantum gravity. One of the most exciting recent developments has been the emergence of good and interesting discrete and quantum analogues of classical integrable differential equations, such as the Painlevé equations and soliton equations. Many algebraic and analytic ideas developed in the continuous case generalize in a beautifully natural manner to discrete integrable systems. The editors have sought to bring together a collection of expository and research articles that represent a good cross section of ideas and methods in these active areas of research within integrable systems and their applications.

Third International Conference on Image Processing and Capsule Networks Aug 23

2019 This book provides a collection of the state-of-the-art research attempts to tackle the challenges in image and signal processing from various novel and potential research perspectives. The book investigates feature extraction techniques, image enhancement methods, reconstruction models, object detection methods, recommendation models, deep and temporal feature analysis, intelligent decision support systems, and autonomous image detection models. In addition to this, the book also looks into the potential opportunities to monitor and control the global pandemic situations. Image processing technology has

progressed significantly in recent years, and it has been commercialized worldwide to provide superior performance with enhanced computer/machine vision, video processing, and pattern recognition capabilities. Meanwhile, machine learning systems like CNN and CapsNet get popular to provide better model hierarchical relationships and attempts to more closely mimic biological neural organization. As machine learning systems prosper, image processing and machine learning techniques will be tightly intertwined and continuously promote each other in real-world settings. Adopting this trend, however, the image processing researchers are faced with few image reconstruction, analysis, and segmentation challenges. On the application side, the orientation of the image features and noise removal has become a huge burden.

16th Conference on Flavor Physics and CP Violation Mar 23 2022

Presenting the proceedings of FPCP 2018, this book reviews the status quo of flavor physics and discusses the latest findings in this exciting area. Flavor physics has been instrumental in the formulation and understanding of the standard model, and it is possible that the direction of new physics will be significantly influenced by flavor sector, also known as the intensity frontier, making it possible to indirectly test the existence of new physics up to a very high scale, beyond that of the energy frontier scale accessible at the LHC. Geometry of Black Holes Jan 21 2022 Black holes present one of the most fascinating predictions of Einstein's general theory of relativity. There is strong evidence of their existence through observation of active galactic nuclei, including the centre of our galaxy, observations of gravitational waves, and others. There exists a large scientific literature on black

holes, including many excellent textbooks at various levels. However, most of these steer clear from the mathematical niceties needed to make the theory of black holes a mathematical theory. Those which maintain a high mathematical standard are either focused on specific topics, or skip many details. The objective of this book is to fill this gap and present a detailed, mathematically oriented, extended introduction to the subject. The book provides a wide background to the current research on all mathematical aspects of the geometry of black hole spacetimes.

Lie Theory and Its Applications in Physics

Apr 11 2021 Traditionally, Lie Theory is a tool to build mathematical models for physical systems. Recently, the trend is towards geometrisation of the mathematical description of physical systems and objects. A geometric approach to a system yields in general some notion of symmetry which is very helpful in understanding its structure. Geometrisation and symmetries are meant in their broadest sense, i.e., classical geometry, differential geometry, groups and quantum groups, infinite-dimensional (super-)algebras, and their representations. Furthermore, we include the necessary tools from functional analysis and number theory. This is a large interdisciplinary and interrelated field. Samples of these new trends are presented in this volume, based on contributions from the Workshop "Lie Theory and Its Applications in Physics" held near Varna, Bulgaria, in June 2011. This book is suitable for an extensive audience of mathematicians, mathematical physicists, theoretical physicists, and researchers in the field of Lie Theory.

Precision Physics of Simple Atoms and Molecules

Mar 30 2020 This volume presents multidisciplinary treatments of important areas and new developments within precision physics. It concentrates on new topics and those not treated in the previous volumes about the precision physics of simple atoms, all published in LNP. For example, it concentrates on the proton structure and its effects on the energy levels, on simple molecules, on atoms somewhat more complicated than hydrogen (such as lithium), on exotic atoms and atoms with exotic nuclei.

Loop Quantum Gravity: The First 30 Years May

25 2022 This volume presents a snapshot of the state-of-the-art in loop quantum gravity from the perspective of younger leading researchers. It takes the reader from the basics to recent advances, thereby bridging an important gap. The aim is two-fold — to provide a contemporary introduction to the entire field for students and post-docs, and to present an overview of the current status for more senior researchers. The contributions include the latest developments that are not discussed in existing books, particularly recent advances in quantum dynamics both in the Hamiltonian and sum over histories approaches; and applications to cosmology of the early universe and to the quantum aspects of black holes.

Advances in Applied Analysis Aug 28 2022 This book contains survey papers based on the lectures presented at the 3rd International Winter School "Modern Problems of Mathematics and Mechanics" held in January 2010 at the Belarusian State University, Minsk. These lectures are devoted to different problems of modern analysis and its applications. Quantum Information Science and Its Contributions to Mathematics

Jun 01 2020 This volume is based on lectures delivered at the 2009 AMS Short Course on Quantum Computation and Quantum Information, held January 3-4, 2009, in Washington, D.C. Part I of this volume consists of two papers giving introductory surveys of many of the important topics in the newly emerging field of quantum computation and quantum information, i.e., quantum information science (QIS). The first paper discusses many of the fundamental concepts in QIS and ends with the curious and counter-intuitive phenomenon of entanglement concentration. The second gives an introductory survey of quantum error correction and fault tolerance, QIS's first line of defense against quantum decoherence. Part II consists of four

papers illustrating how QIS research is currently contributing to the development of new research directions in mathematics. The first paper illustrates how differential geometry can be a fundamental research tool for the development of compilers for quantum computers. The second paper gives a survey of many of the connections between quantum topology and quantum computation. The last two papers give an overview of the new and emerging field of quantum knot theory, an interdisciplinary research field connecting quantum computation and knot theory. These two papers illustrate surprising connections with a number of other fields of mathematics. In the appendix, an introductory survey article is also provided for those readers unfamiliar with quantum mechanics.

Random Matrix Theory with an External Source Jul 27 2022 This is a first book to show that the theory of the Gaussian random matrix is essential to understand the universal correlations with random fluctuations and to demonstrate that it is useful to evaluate topological universal quantities. We consider Gaussian random matrix models in the presence of a deterministic matrix source. In such models the correlation functions are known exactly for an arbitrary source and for any size of the matrices. The freedom given by the external source allows for various tunings to different classes of universality. The main interest is to use this freedom to compute various topological invariants for surfaces such as the intersection numbers for curves drawn on a surface of given genus with marked points, Euler characteristics, and the Gromov-Witten invariants. A remarkable duality for the average of characteristic polynomials is essential for obtaining such topological invariants. The analysis is extended to nonorientable surfaces and to surfaces with boundaries.

Exoplanet Science Strategy Jul 03 2020 The past decade has delivered remarkable discoveries in the study of exoplanets. Hand-in-hand with these advances, a theoretical understanding of the myriad of processes that dictate the formation and evolution of planets has matured, spurred on by the avalanche of unexpected discoveries. Appreciation of the factors that make a planet hospitable to life has

grown in sophistication, as has understanding of the context for biosignatures, the remotely detectable aspects of a planet's atmosphere or surface that reveal the presence of life. Cosmology, Gravitational Waves and Particles

Sep 04 2020 In February 2016, physicists announced the breakthrough discovery of the gravitational waves, which were predicted by Albert Einstein in his century-old theory of General Relativity. These gravitational waves were emitted as a result of the collision of two massive black holes that happened about 1.3 billion years ago. They were discovered at the Laser Interferometer Gravitational-Wave Observatory (LIGO) in the United States and thus marked a new milestone for physics. However, it remains unclear to physicists how the gravitational interaction can be included in the Standard Theory of particle physics which describes the electroweak and the strong interactions in our universe. Non-centralized Optimization-Based Control Schemes for Large-Scale Energy Systems

Multiple Messengers and Challenges in

Astroparticle Physics Oct 25 2019 This book, designed as a tool for young researchers and graduate students, reviews the main open problems and research lines in various fields of astroparticle physics: cosmic rays, gamma rays, neutrinos, cosmology, and gravitational physics. The opening section discusses cosmic rays of both galactic and extragalactic origin, examining experimental results, theoretical models, and possible future developments.
